- Perform immediate or reported repairs for vehicle issues.
- Calibrate truck instrumentation and sample scales as per schedule.
- Drive safely under all conditions, ensuring the safety of self and assistant.
- Supervise loading at silos and manage the loading of holes according to blast designs.
- Ensure compliance with all legal paperwork and permits required in the truck.
- Perform truck greasing, cleaning, and routine maintenance.
- Execute density sampling and product analysis before loading.
- Complete all truck performance and administrative documentation.
- Submit loading sheets and delivery notes signed by the customer daily.

- Report deviations to the Foreman and ensure SHERQ compliance in all tasks.
