Role Purpose

The Technical Scout plays a key role in our orchard monitoring system, ensuring early detection of pests, diseases, and operational deviations across our date palm orchards. Key Responsibilities

Field Monitoring & Scouting

- Operate scouting equipment such as GPS-enabled devices, sweep nets, magnifying lenses, pheromone traps, and sticky traps.
- Conduct rapid sweep surveys beyond designated data trees to identify emerging threats.

Sample Collection & Data Management

- Collect and label fruit, leaf, and soil samples for laboratory analysis and pest identification.
- Maintain orchard history records, including block-specific data, pest trends, and treatment outcomes.
- Support yield forecasting by providing timely and accurate scouting reports.

Research, Compliance & Improvement

- Assist with research and development initiatives related to cultivation, harvesting, and post-harvest handling.
- Provide technical insights to improve scouting protocols and pest control strategies.
- Ensure compliance with phytosanitary regulations and internal SOP's.
