  - Plan and deliver training sessions on Health & Safety, pesticide handling, and related standards.
  - Review agronomic practices and implement management recommendations.
  - Support senior management with SOPs, Integrated Pest Management (IPM), Integrated Crop Management (ICM), and long-term planning.
