PURPOSE:

The incumbent will be responsible for ensuring the availability, reliability, and efficiency of CENORED's distribution network and infrastructure in Okahandja and Otjinene, as well as the associated rural medium- and low-voltage networks that supply settlements and various customers in the Omaheke Region. This includes effective planning, resource management, and maintaining the network effectively.

KEY RESPONSIBILITIES, AMONGST OTHERS:

- Overall responsibility for ensuring the electricity supply to CENORED customers in the respective areas is maintained.
- Ensure that the company adheres to all legal requirements and regulations regarding planning, distribution networks, designs, constructions, operation and maintenance.
- Prepare and manage budgets, maintenance records, and service contracts.
- Provide technical expertise and guidance to the company regarding specifications for new network assets and technologies.
- Liaise daily with superintendents, providing instructions on weekly and daily operations to ensure the network functions reliably and effectively.
- Managing and resolving supply interruption and supply quality incidents, as well as reactive repairs, and routine maintenance.
- Develop and execute maintenance strategies for the respective networks
- Provide technical leadership and operational support, where required, to company staff, contractors, and other parties carrying out activities on, or in proximity to, the company's electricity networks.
- Drive adherence to, and continuous improvement of, standards, processes and procedures relating to the operation of the company's electricity networks and associated customer service.
- Responsible for fulfilling safety obligations and supporting the company's safety, health, and Environmental efforts.
